<b>Membership:</b>		<b>Membership year: 01 September - 31 August</b>
Joining Fee	\$25.00	The joining fee, payable once only by all new members (providing membership is kept up to date), covers the issue of initial administration, etc. Single, Family and Company members enjoy full voting rights and may register any number of horses. Associate members have no voting rights and cannot register any horses but can transfer AWHA Ltd registered horses into their name. The insurance levy applies to all membership classes and is compulsory.

<b>Registration (including IFS &amp; ET Foals &amp; Horses)</b>	\$80.00 \$72.00*	Once only fee that covers the registration of AWHA Ltd eligible foals and horses. (*10% discount for 10 or more).
<b>Mare Classification</b>	\$85.00	<b>Warmblood mares:</b> must be registered in the Studbook Appendix or Register (and eligible) prior to classification. <b>Thoroughbred and Anglo Arabian mares:</b> classification fee includes the cost of registration and classification. Please note: Branches may apply a travel fee for private classifications.
<b>Transfer of Ownership</b>	\$20.00	<b>Original</b> papers must be signed by both parties and returned to the Federal Registrar. All new owners must be financial members of the AWHA Ltd. <b>One free transfer</b> of an AWHA Ltd registered horse with each <b>new membership</b> .
<b>Name Change</b>	\$200.00	Stud Prefix/Suffix <b>cannot</b> be changed without the Breeder's consent in writing. Please apply in writing to the Federal Registrar for changes to the remaining portion of the name.
<b>Addition of Prefix / Suffix</b>	\$50.00	
<b>Duplicate Papers</b>	\$60.00	Please apply in writing to the Federal Registrar with a Statutory Declaration stating the reason for loss.
<b>DNA Typing</b>	\$90.00	Registration process or application requiring <b>DNA typing must be applied for and approved</b> . Payment for DNA typing must be paid <b>before</b> the sample is taken.
<b>DNA Typing + FFS1</b>	\$120.00	Fragile Foal Syndrome – Type 1 (FFS1) testing is available for an additional \$30 inc. GST <b>when carried out at the same time</b> of parentage/validation testing.
<b>BT Activation</b>	\$25.00	DNA-Buffy Coat activation may be available for some bloods. Please check with the Federal Registrar for activation eligibility.
<b>Upgrade Fee</b>	\$25.00	For any horse upgrading from the WPRB (ex WID) or Studbook Appendix to the Studbook, or between Studbook categories outside of normal upgrading procedures (such as post classification).
<b>Colt Selection</b>	\$500.00 (+ travel subsidy if applicable)	Full fee to be paid no less than <b>6 weeks prior to</b> the Colt Selection date. No refunds after this time without a veterinary certificate. Conditions apply. Only open to Thoroughbred, Anglo Arabian and AWHA Ltd Studbook Appendix registered colts within the age range. <b>Special consideration for colts outside of the specified age range with Federal Board approval</b> . Please note: this fee does not include any Service Certificate books which must be purchased separately (see fees below).

<p><b><i>Performance Acceptance Assessment</i></b></p>	<p>\$500.00  (+ travel subsidy if applicable)</p>	<p>This fee applies to colts who are eligible to be re-presented (providing they are within the guidelines) as well as recorded stallions who have reached FEI performance level and have been presented for AWHA Colt Selection previously. This fee also applies to the assessment of stallions for Performance Acceptance. AWHA Ltd vet check and DNA typing (at owner's expense) criteria still applies to the above colts/stallions. Please note: this fee does not include any Service Certificate books which must be purchased separately (see fees below).</p>
<p><b><i>Service Certificate Books</i></b></p> <p>SBSCB (Studbook Stallions)</p> <p>NSBSCB (Recorded Stallions)</p> <p>Document of Mating (DoM) (WID/SBApp Stallions).</p> <p>Individual Service Certificates</p>	<p>\$100.00</p> <p>\$110.00</p> <p>\$150.00</p> <p>\$25.00</p>	<p><b>SBSCB:</b> stallions that have passed AWHA Ltd Colt Selection or equivalent. Applications to be submitted to the Federal Registrar.</p> <p><b>NSBSCB:</b> stallions scoring between 65% and under 70% at AWHA Ltd Colt Selection. Applications to be submitted to the Federal Registrar.</p> <p><b>DoMB:</b> stallions scoring less than 65% at AWHA Ltd Colt Selection, unrepresented or ineligible stallions. Stallions must be AWHA Ltd vet checked and DNA typed. Applications available from the Federal Registrar.</p> <p><b>ISC:</b> where the stallion does not have a Service Certificate or DoM Book and service documentation is required.</p>
<p><b><i>IFS Stallion Listing (imported frozen/chilled semen)</i></b> (Listed Stallions)</p>	<p><del>\$70.00</del> \$0.00</p>	<p>Stallions must meet the AWHA Ltd's criteria and must be Licensed with a recognised Studbook. This enables the stallion to be accepted and his progeny registered by the AWHA Ltd. Please note: this fee does not include any Service Certificate books which must be purchased separately (see fees above).</p>
<p><b><i>Change of Paper</i></b></p>	<p>\$10.00</p>	<p>Fee charged when new registration papers are issued e.g. when brands are removed, microchip number added, etc. Changes not charged when done with a Transfer of Ownership or Upgrade.</p>
